

## **Building Service Worker Program**

#### January 26 to February 20 - Campbell River

#### **Limited Seating**

This program encompasses theoretical and technical skills training required to work in the building service custodial field. Topics include: attitudes, ground rules, WHMIS, blood borne pathogen and sharps safety, hanta virus awareness, basic cleaning chemistry, cleaning procedures overview, interior office cleaning, restroom cleaning, daily floor maintenance and classroom cleaning. Curriculum also encompasses instruction and hands on training for maintenance of all types of resilient and hard floor surfaces. In addition to modern methods for daily and periodic commercial carpet care, including a detailed examination of systems, chemistry, and equipment; preventative cleaning, interim cleaning, restorative cleaning, carpet protection and topical treatments, spot removal, and odour control. The Transition to Employment component assists participants with resume preparation and job search skills and resources.

#### **Courses include:**

- Foundation/Transition to work Skills
- Building Service Worker Level 1
- Building Service Worker Level 2: Hard Floor Care
- Building Service Worker Level 3: Carpet Care
- Building Service Worker Practicum

### The program also includes the following certification:

- WHMIS
- Worksafe Preventing and Investigating Musculoskeletal Injury
- Occupational First Aid Level 1
- Building Service Worker Certificate

In the Province of British Columbia you must have a Security Workers License to work as a security guard. This program is being funded by the Government of Canada through the Canada-British Columbia Job Fund. Tuition and materials are available for participants that meet the criteria of the program. The program includes:

- Introduction to private security
- Legal rights and responsibilities
- Patrol duties and responsibilities
- Personal Safety
- Exam Preparation
- Essential Skills and Employment Transition
- Safety Training (OFA Level One and WHMIS)
- Traffic Control/Flag Person Training
