You’ll be responsible for hoe-chucking and staging wood in alignment with WorkSafeBC Part 26 and our strict company safety standards. The Role You aren’t just moving logs; you are managing the corridor. You will be responsible for:

- Safe Log Movement: Moving logs in a controlled manner to prevent roll-outs, kickbacks, or uncontrolled movement.
- Tilt-Head Management: Operating the tilt-head strictly within rated limits to avoid cylinder or pin failure.
- Terrain Assessment: Assessing ground stability and maintaining safe machine positioning on steep or broken North Island ground.
- Crew Coordination: Using positive radio communication to maintain a 300 ft (90 m) danger zone and coordinating with processors and bunchers to avoid conflict points.
- Decking: Building stable log decks with solid bases to prevent shifting or sliding.
